Two weeks later we appeared before the House Higher Education Sub-Committee to speak about the Activity Fee. Also present were UT system Executive Vice-President Joe Johnson and Vice-Chancellor Phil Scheurer. The sub-committee refused to buy Johnson's "we like it like it is" attitude. One representative told him, "you just made a bum decision." Then, the sub-committee unanimously approved the bill and sent it

UTK students face several problems concerning the mandatory "Activities Fee" they pay to support non-instructional programs.

1) Here at UTK, students have no control over how the fee is disbursed, and what little "input" we have does not work. Nationwide, approximately 78% of universities that have activities fees allow student control of their activities fees.

2) The Activity Fee is supposed to be used to fund non-instructional (but educational) programs which are open to all students.

3) The Administration has claimed that Women's Athletics Funding for Women's Intercollegiate Athletics from the Activities Fee would stop at \$1

million (The Daily Beacon 17 September 1984) but it is now at \$1.2-\$1.3 million annually. Intercollegiate Athletics is not an educational program open to all students, and since the UTK Athletic Department has a \$14 million dollar budget, why doesn't it fund women's athletics???

4) The Athletic Department has offices, lockers, and equipment in the Student Aquatic Center, and uses the facility to practice in. Yet, the only money they contribute to the running of the pools is \$200 per swim meet.

5) The Administration does not want the Activities Fee to be an issue, and has requested the candi-

According to Title IX, UTK must fund women's athletics, but the law does not say where the money must come from. Most universities fund



women's athletics by appropriating money from a general athletic budget. This means that the money making sports pay for the unprofitable ones. Here at UTK, women's athletics has a separate athletic department. UTK is the only school in the SEC, and one of only 13 universities nationwide to do this. But most of these separate women's departments still get financial support from the highly profitable men's sports. At UTK, none of the profit from men's athletics goes to support the women's programs. Because of this, and the fact that the law says someone must pay for women's athletics, the students are paying for it. Mark and Bob feel that the Women's Athletic Director should be in complete control of her own budget — but we do not feel that students should subsidize the Athletic Department's \$14 million budget with and extra \$1.5 million. We favor eliminating all funding for intercollegiate athletics through the Activities Fee.

Joe Johnson, Vice President of the UT system, is setting up a meeting with students, including Mark and Bob, to do something about the funding of athletics through the Activities Fee. This agreement was reached with the help of Representatives

Steve Bivens and Shirley Duer of the State Legislature. Rep. Duer had planned to send a bill which passed the sub-committee unanimously to the full Education Committee. Her bill would have required a second activities fee that would not include any money for intercollegiate athletics. We all feel that a law would not be the best solution. However, if the administration continues to talk, without listening to student concerns, and nothing is worked out by June 1, the Legislature will take the matter up again in the fall — and we will be there. We are committed to action and following through on issues of student concern - unlike many past members of SGA.

Bob recently sponsored a bill in the SGA Senate requesting the Administration publish the balances of Activities Fee accounts which keep money from one fiscal year to the next. For most accounts, if the money Continued on Page 2



Rebuild A Working Relationship With Whom?

Many candidates seem to feel that SGA needs to "continue to rebuild (or build) our relationship with the administration." Why is it that SGA's junior politicians always want to build a "good" relationship with the

administration? Is it because every time a student disagrees with an administrative position, it is taken as an insult by the administrators? The admini-

stration often does not bother to listen to what students and faculty are saying, and do not seem to direct their efforts towards solving complaints. Rather, by their actions they assure us that they are happy with the system and that it has to be the way they currently have it set up.

Why should we worry about having a "good" relationship with the administration? Often, such a relationship simply means that the students meekly agree to whatever the administration says. We are not wor-

ried about offending the administration if that is what it takes to represent the students.

We feel that our relationship is about as good as it is going

to be for a while and that SGA's efforts would be better spent on trying to build a better working relationship with the Faculty Senate. We feel that more cooperation and exchange of information on issues of concern to each body would give students and faculty an even stronger

voice in matters that concern them. After all, both groups are often concerned about the same issues, such as parking. One proposal that we would like to see immediately implemented is that the Faculty Senate should send SGA a copy of the minutes of each of its meetings. SGA already sends a copy of its minutes to the Faculty Senate, so a return of this minimal communication would be a good place to start. We also think that the Faculty Senate and the SGA Senate should meet together once a semester.

SGA needs to build up its credibility with the students. The first step in this direction is to get students involved who are willing to show up and work — not just to be elected and then never do a damn thing. The biggest problem that SGA now has is

that many members do not show up for meetings, and many of those that do show up are not actively involved in projects. Senators constantly complain that not enough research has been done, but when asked, they do not want to do this research themselves.

Rusty Gray and Pat Hunt, current SGA president and vice-president respectively, have had much difficulty in firing those members who never showed up and did not fulfill their obligations. Mark and Bob will have no problem with firing someone that doesn't do their job. We do not have a large party, so we have no obligations to fill positions with party members, or reasons to keep a poor worker. We will select students according to their merit and not their party affiliation.

Library Needs More Books and Equipment

How many students have noticed that the library is nice, but it doesn't have enough books. How many students have been forced to stand in line waiting to use equipment such as a microfilm machine? These problems are a result of a Library Endowment Fund that has not grown sufficiently over the years. The fund is too small to buy many new books and cannot be used to purchase new equipment. Mark and Bob very strongly support an immediate and drastic increase in the amount of this

fund, and the creation of a Library Equipment Fund. As the age of instant information encroaches upon us, the need for expensive, modern library equipment should be obvious. At worst, new, working microfilm machines and copiers are needed. The library and administration need to launch a large to

tion need to launch a large tundraising campaign, possibly making it an annual event.

stration and possibly alumni, the endowment fund can be increased to a level where the Library can purchase many important volumes each year and also work toward replacing the stone age equipment currently in use. Until we amend the SGA Constitution to eliminate the administration payoff - uhm, the SGA stipends, we will sign over any checks received to the Library Endowment Fund to start the ball rolling.

The libraries should be convenient for student use, and so as long as the

book and equipment shortages are in existence, SGA should help the library and administration in getting sufficient funds. The library should also be open longer for student use. Mark has already sponsored a bill asking for the study areas in the library to be open 24 hours, the Reference and Periodical

sections open until 2 a.m., and the entire library open until midnight during exams. We are happy that the library implemented this proposal.

The Money Pit

Everybody knows what a bitchit is to park on campus. You pay the highest fees in the state for a hunting license. That's because the Traffic and Parking Authority (TPA) sells more stickers than there are spaces and then says that we have plenty of parking spaces! Bullshit. It is true you can usually find a space, but how far from class? It is humiliating to have to pay an exhorbitant fee and then hike a mile to class. And after paying these high fees, only to dis-

cover no spaces are available, the TPA kindly remembers your contribution by sending the student ticket writers from Hell after your almost legally parked car. After all, the fees are not enough,

they are desperate for more of your money.

UTK recently announced that they would soon begin constructing a new parking garage. But who is the garage really for??? Who else, but the Athletic Department. general or capital fund. This capital fund is how the outdoor pool repairs were paid for, the sports bubble was set up, and the Nautilus Equipment was paid for. These expenditures total approximately \$1.5 million. The

reason for the bill is because by looking at the budget, you cannot tell where this money came from.

As long as some facet of SGA does not have veto power over activities fee allocations, SGA will have no power other than lobbying the various governmental bodies which can effect change through legislation. It is just a fact that money talks and bullshit walks. Mark and Bob feel that the students will continue to walk without at least veto power over activities fee allocations.


A far fetched scenario you say? Hardly. Recently The Daily Beacon has done stories demon-

strating that problems exist between the Knoxville Police and residents of Fort Sanders and other off campus housing areas. Several UTK Rental Property residents have had motorcycles stolen and neither the UT Police nor the Knoxville Police would respond, citing jurisdictional conflicts. These stories have shown that the Knoxville Police often refuse to answer calls in non-campus areas, instead referring them to UTK Police, who in turn say they do not have jurisdiction in off campus areas. This cannot be allowed to continue. Residents of off-campus housing, regardless of the area, must be guaranteed the same police protection that residents of other Knoxville communi-



Another concern in the area of crime is that UTK does not include crimes against students in the Fort Sanders area in its crime statistics. This means that UTK's crime statistics are lower than what the actual student community experiences. We feel that crime statistics for off-campus housing areas should be available in the Off-Campus Housing Office, so that students are more aware of the crime rates in potential living areas.



Okay, Jack and Phil, it's time to stand behind all those nice statements you made about how UT abides by Title IX and do so! What is Title IX? It is a Federal law that says men's and women's athletic programs must be comparably funded. UT administrators claim to abide by Title IX, but do they? No!

The best example is Pat Head Summit versus Don Devoe. Mrs. Summit is the Women's Basketball Coach. Under her leadership, the Lady Vols have exploded into national prominence. They are always a standout group leaders as athletes and students. They reach the Final Four year after year after year. They were the 1987 NCAA Na-

tional Champions and returned to the Final Four again this season. Ob-

viously, Coach Summit has worked incredibly hard and deserves to be amply rewarded for achievements. Why then does she have a salary of only \$48,335 when Don Devoe makes \$68,900?!

This is a crock! Under Don Devoe the men's program has steadily plummeted to new lows of performance. They have not reached the NCAA Tournament in many years, and have never moved past the second round of the NCAA's. His leadership has led to shoplifters representing the University of Tennessee. He has a losing record over the past 3 years combined and cannot seem to recruit even players who live in Tennessee.

How can Jack and Phil justify this farce? They can't! Not even Socrates could explain this bullshit away on his best day. UT must immediately redress this situation. Of course, they could reduce Devoe's salary, or raise Summit's salary. Actually, the best solution is to increase Summit's salary and reduce Devoe's - probably by firing him.

SGA: FROM YOUR POCKET TO THEIRS

Currently the SGA President and Vice-President receive a monthly stipend from the administration. The President receives approximately \$200.00 and the Vice-President receives approximately \$150.00 a month for their activities, or lack thereof. The money comes from the SGA's \$30,000 a year budget, financed through the Activities Fee. We feel that with SGA officers receiving money from the administration that they become mouthpieces for the administration, loosing their student perspective. We feel that students should be volunteering to serve other students, not taking pay offs from the administration. Are SGA officers employees of the administration or public servants? The SGA President and Vice-President receive free parking privileges, which allows them to park in any staff or student lots. We oppose this, as the officers of SGA are just students who can pay to park like other students.

Pat Hunt, current SGA Vice-President and current candidate for SGA President, desires to form a committee that will help raise funds to be spent on parking. This is quite interesting in light of the facts that he currently doesn't pay to park and UTK already has the highest parking fees of any state institution. We think that UTK students are already paying too much for the poor parking facilities available to students. They suggest that the Traffic and Parking Authority examine ways to cut their very thick budget. The free parking privilege for SGA Officials is another cost that the student body has to absorb.

Mark and Bob will work toward eliminating the Stipend and the Free Parking for SGA Officials by amending the SGA Constitution and refusing the payola. We will publicly display the SGA accounts and personal records to show that they receive no money from the administration, when elected.

"Society has long ago decided on this ethical question, and I'm not naive enough to believe prohibition will re-occur. I find it difficult to recouncile the fact that students in our dormitory system are denied the rights which are freely available to them in private housing in the immediate area of campus. Frankly, I am not comfortable with what may be some inevitable hypocrisy. I believe that the entire subject of alcohol deserves more attention than it has received..."

LEGISLATIVE INTEREST GROUP SHOULD BE STRONG

The Legislative Interest Group is a Student Services Committee responsible for lobbying Federal, State, and Community governments with student concerns. The Legislative Interest Group should be one of the most important student services committees. Over the past few years SGA Officials that have been successful in bringing about any major changes have all had strong Legislative Interest Groups. But for the past eight years SGA has neglected this Student Services Committee to a point that it is ineffective, and as a result SGA has lost the only power that is possible without financial power. For years now SGA has allowed the administration to dictate what can and can't be addressed by this committee. This is a dirty shame, because students can effectively lobby the Federal, State, and City governments. For example when State Senator Bill Owens was a student at UTK he was involved with establishing a student as a member on the Board Of Trustees. The UT administration lobbied against this, and yet the students were successful due to effective lobbying. Bob and Mark are currently demonstrating that this can still happen, as they lobbied the State Legislature on the Activities Fee Issue and forced the administration to come to the bargaining table.

Mark and Bob feel that this group should be much more active, and MUCH larger. This group should actively lobby the State Legislature and the Tennessee Higher Education Commission on issues of student importance, like Library funding and our very high parking and Activities Fee. They also need to lobby local governments on issues like the

oppressive amusement tax. The Student representative on the Board of Trustees should take care of student concerns. But it is obvious that they have not been effective in representing student concerns during the 3 or

4 meetings held each year. The Legislative Interest Group should also helplobby the Trustees. Mark and Bob also feel that when LIG lobbies they should be lobbying free of administrative direction (although it is nice if both of us are lob-

bying for the same goals.) However, in recent years it has become apparent that LIG's trips are often conducted like field trips in which the

students are led around like a class limiting their effectiveness concerning real lobbying. It has also come to Mark and Bob's attention that the UT Administration often says one thing and then lobbies another way (talk to
